Recital Information

We anticipate recital tickets to go on sale on Monday, May 17th. Initially everyone will be allotted a total of 6 tickets for either of the shows. The tickets can be split up between both nights, or all of them can be used on the same night. If you would like any additional tickets, any unsold tickets will go on sale Tuesday, June 1st. Please be aware that this year's recital will be open seating, and tickets will be made available on a first come first serve basis. There are three remaining tuition payments. You will not be eligible to purchase tickets for this year's recital unless all tuition and costume payments are paid in full. All level II classes (and higher) will be performing both nights of the recital. Contact the office for clarifications or questions.

Our annual recital will take place at Larkin High School in Elgin on June 11th and 12th. Dress Rehearsal will take place on Thursday, June 10th. Please keep the entire weekend free.
